2. As per approved norms, the cut off is applied in each level of selection process i.e. Written Test, Group Discussion (GD) and Personal Interview (PI).
3. **At each level (WT, GD and PI)**, cut off is maintained with 32% as applicable for ST and SC candidates. This has been duly published in official website of JSLPS.
4. The written test score is converted into 60% weightage.
5. Further, the selection is also based on credential check as presented by candidates. However, the final check of credential will be made once again before joining.
6. In case any discrepancy or deviation is noticed/identified, the result of concerned candidates will be ceased.
7. JSLPS reserves all right to take any decision with regards to this result.
8. All due check has been applied while preparing this web notification. In case of any printing mistake, final result submitted by SIDS will be referred.
9. For District Accountant Position, GD is not applicable and hence weightage included in PI.
