Under Rule 4 of Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Audit of the Schemes rules, 2011, requires Government of Jharkhand to identify or establish independent organization, " Social Audit Unit" (SAU) to facilitate conduct of the Social Audit of MGNREGA works. Government of Jharkhand has decided to in-house the SAU within JSLPS, society under Rural Development Dept and capacitating the SAU for conducting the Social Audit of other Rural Development Schemes as well.
