Background: Jharkhand State Livelihood Promotion Society (JSLPS) under the aegis of Rural Development Department, Government of Jharkhand is an autonomous Society registered under the Societies Registration Act, 1860. JSLPS's mandate is to promote livelihoods amongst disadvantaged communities across the State to reduce the poverty. JSLPS has been designated by the Government of Jharkhand to design and implement the Aajeevika Project of Ministry of Rural Development, Government of India in the State. In this backdrop, The District Mission Management Unit, Garhwa of the Society requires CRP Kit items for drive use in BMMUs.

Objective: - Selection of Agency for Supply of CRP Kit items.

A. Scope of Work:-

1. Supply of **CRP Kit** to District Mission Management unit , Garhwa.

B. Key requirements:-

1. A reputed agency with a valid GST Invoice number.
 2. Agency should have to make commitment of supply of CRP kits at time and capable to fulfill the demand as issued from the District Mission Management unit, Garhwa.
 3. The price quoted of **CRP Kit** should be exclusive of all taxes (Where applicable) and should be valid for 06 month and free delivery at Site.

C. Conditions Clause:

1. The goods/items/stores should be supplied within 15 (Fifteen) days from the date of issue of purchase order/supply order.
2. The goods/items shall be delivered to DMMU-Garhwa , between 10.30 AM to 04.30 PM during working days. Unloading of goods and delivery to store at above mentioned place shall be responsibility of the firm.
3. The supplier will be liable to replace the rejected /damaged item of **CRP kit** within 03 days, failing which the legal action will be taken as deemed fit by the organization.
4. The Tenderer must confirm in writing that the goods supplied by them shall be as per specification of goods mentioned in the Tender Enquiry and in case any duplicate/identical goods of varying quality supplied by them, the contract shall be cancelled and goods shall be purchased from the L-2 quoting firm or market, and the difference in price would be recovered from L-1 supplier.
5. The payment will be made through RTGS/NEFT as applicable with in 15 days from the date of receipt of bill in triplicate.
6. This office reserves the right to reject or to accept any quotation, in whole or in part without assigning any reason thereof.
7. The contract may be placed with one or more than one firms depending upon rates and other factors viz L.1 rates, quality of the products etc.

8. Tenders received after the stipulated date and time or through email/fax shall not be accepted.
9. The tenderers are requested to read and understand the terms and conditions of the contract mentioned in the foregoing paragraphs before sending their quotations, as no violation of the aforesaid terms and conditions shall be permitted once the quotation is accepted by this office.
10. The order will be placed with the lowest responsive bidder to supply of **CRP Kit** If the selected agency or bidder did not execute the order or violate the terms and conditions, the firm will be blacklisted from this organization.
11. Any legal disputes arising out of this are subject to the jurisdiction of the court located at Garhwa only.
12. The tenders shall be opened in JSLPS Office at Garhwa 16.30 hours of the last date of submission of tender.
13. Any delay by the supplier in the delivery of the items shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part thereof subject to a maximum of 10% of purchase order value which will be deducted from the payment due
14. Notwithstanding, anything contained as above The District mission management unit, Garhwa of JSLPS reserves the right to accept or reject any or all bid (s) and cancel the bidding process at any time without assigning any reasons for such act to the bidders
15. Suppliers/Bidders having Experience of Supplying goods to District Administrators/Departments in Garhwa are Encouraged to Participate.
16. Bidder has to Submit a Self declaration stating that they are not debarred/blacklisted from any Govt Department/offices
17. Tender Validity period will be 45 days from the date of bid open date.
