TERMS AND CONDITIONS

1. The Quotation /tender shall be for the full quantity of all item(s) as described in the schedule of requirement and specification in **Annexure- I**, price format at **Annexure-II** & Consignee list at **Annexure-III** . Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
2. The quoted rates shall include the excise duty and the bidder's cost towards DTP/design, insurance, packing & forwarding, transportation and delivery charges consignee placed.
3. GST should be clearly mentioned separately in the price sheet.
4. Each bidder shall submit only one bid & the firms can verify the samples at JSLPS office prior to submit the tender.
4. Tenders shall remain valid for a period not less than **30 days** from the date of opening of the bid.
5. Notwithstanding the above, the purchaser reserves the right to accept or reject any bid(s) and to cancel the bidding process at any time prior to the issue of Purchase Order.
6. The purchaser reserves the right at the time of placement of purchase order to increase or decrease the required quantity depending upon demand and supply situation during award of contract period.
7. Before printing, the supplier shall receive the samples from JSLPS.
8. The delivery should be completed within **10** days from the date of receipt of the confirmed purchase order at consignee placed.
9. Any delay by the supplier in the delivery of the items shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part thereof subject to a maximum of 10% of purchase order value which will be deducted from the payment due.
10. Before delivery the selected firm will be informed to this office for post delivery inspection, if required, Delivery will not be made if the materials are not as per the specifications.

12. **Eligibility criteria:**

- Fungicide and pesticide license required for insecticides supplier.
- Authorization required for Rocking sprayer supplier.
- Copy of GST Registration certificate.
- Rate should be quoted as per the format for all items.
- Single price for each item.
- Alternative price shall not be accepted.

13. The bids are liable to be rejected if any of the above conditions is not complied with.

14. The tender will be opened in presence of the representative of the bidders at 01.30 PM hours of the last date specified in the tender.

15. **Issue of Purchase Order.**

The Purchase Order will be placed to the selected bidder whose bids has been determined to be substantially responsive and who has offered the **lowest individual price**. The terms of the accepted offer shall be incorporated in the purchase order. The individual price shall be taken into consideration not package price.
