### TERMS AND CONDITIONS

1. The tender shall be for the full quantity of all the item(s) as described in the schedule of requirement and specifications at **Annexure-I**. The format for price bid is specified in **Annexure- II** which should be used at the time of submission of tender.
2. The quoted rates shall include the excise duty and the bidder's cost towards insurance, packing & forwarding, transportation, installation and delivery charges in the consignee place.
3. The selected bidder will provide necessary training on operation of the machine properly at the time of installation and also provide free support and maintenance for a period of one year from the date of installation.
4. Delivery will be made at different location of the State as per the consignee list placed at **Annexure-III**.
5. GST should be clearly mentioned separately in terms of percentage in the price sheet.
6. Each bidder shall submit only one bid, alternative bid or any conditional offer shall not be accepted.
7. The rates quoted by the bidders shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
8. The Prices shall be quoted in Indian Rupees only.
9. Evaluation will be made package wise and the lowest evaluated responsive price shall be taken into consideration
10. Normal commercial warranty/guarantee shall be applicable to the supplied goods.
11. Tenders shall remain valid for a period not less than 45 days from the date of opening of the bid or from the last date specified in the tender.
12. The delivery and installation should be completed within 30 days from the date of receipt of the purchase order.
13. Any delay by the supplier in the delivery of the items shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part thereof subject to a maximum of 10% of purchase order value which will be deducted from the payment due.

16. **Issue of Purchase Order.**

The Purchase Order will be placed to the selected bidder whose bids has been determined to be substantially responsive and who has offered the lowest evaluated package price. The terms of the accepted offer shall be incorporated in the purchase order.

17. Payment shall be made immediately on delivery and acceptance of the goods according to the supply order in support of production of bills, warranty certificate etc.

18. Any efforts by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

19. The tender will be opened in the **RSC office Dumri ,Gumla** 4.30 PM on the last date 31/08/2020 specified for submission of tender.

20. Notwithstanding the above, the purchaser reserves the right to accept or reject any bid(s) and to cancel the bidding process at any time prior to the issue of Purchase Order.
